## TERMS AND CONDITIONS

**1. Responsibility:** Parents/legal guardians are fully responsible for the above student(s)' safety and belongings in all activities associated with the Center for Chinese Learning at Stony Brook (CCL). Parents/legal guardians hereby consent and willfully waive their right to bring claims or legal actions against the CCL volunteer staff members (including but not limited to principals, board members and teachers of the School) or the School itself in case there is an accident or incident on the school premise or field trips relating to school activities. It is parents' responsibility to remember and show up on the assigned on-duty day(s).

**2. Refund:** A) 80% refund within the first 4 weeks of 1<sup>st</sup> class. No refund after the end of the 4<sup>th</sup> week. B) A written request for withdrawn is required. C) Special situations will be considered on an individual base; a written request and appropriate proof will be required. The refund amount will be prorated.

**3. Switching class:** Student who wishes to switch the class should submit a written request to the board stating the reasons (or have the parent to do so) within the first 4 weeks of the academic year. No request will be accepted after 4<sup>th</sup> week. It is the board, not the teacher, who will make the decision to approve or deny the request. A qualifying exam may be required. The student can attend the requested class only after the request is approved by the board.

**4. Culture class:** CCL reserves the right to change or cancel any culture classes due to the reasons such as insufficient enrollments, lack of teachers etc., without prior notice.

**5. Discipline:** All students must follow the safety guidelines of the school and the instructions from the teachers. Students who fail to do so will be given warnings or removed from the school. No tuition refund will be given if the student is removed from school.
